



The Nevada Restaurant Association works to promote the health and well-being of our businesses by offering practical guidance for the wellbeing of our employees, customers, and operators. Recently there have been temporary changes to local regulations governing alcohol sales, allowing limited takeout and delivery options. As we plan for reopening and recovery, we want to continue to promote responsible practices that ensure the safety of all parties involved. Below are a few recommendations our association has developed with the help of local restaurants to ensure responsible operations. Please observe the different alcohol restrictions that vary by jurisdiction and ensure your operations comply with local law.

Best Practices for Takeout of Packaged Alcohol:

**City of Las Vegas, North Las Vegas, Henderson, Washoe County, Clark County**

- Valid proof of the recipient's identity and age (21 or older) MUST be obtained at the time of pick up.
- Alcoholic beverages purchased via takeout must be for personal use only, not for resale.
- Sales should be limited to only alcoholic beverages the business is currently licensed to sell.
- All alcoholic beverages must be in sealed containers and comply with open container laws, therefore it must be transported in the trunk of the vehicle or, if the vehicle does not have a trunk, behind the last upright seat of the vehicle.
- We recommend alcohol be packaged in a stapled or sealed paper bag to ensure its contents have not been opened or tampered with.



Best Practices for Delivery of Packaged Alcohol:  
**City of Las Vegas, North Las Vegas, Clark County, and Washoe County**

- Valid proof of the recipient's identity and age (21 or older) MUST be obtained at the time the alcohol is delivered.
- Alcohol must be delivered in sealed containers and by the business owner or an employee of the business who is older than 21. Anyone delivering alcohol must have an unexpired alcohol awareness card and another other necessary work card for jurisdictions in which they are delivering. Third party delivery (e.g., Postmates, GrubHub, Uber, Lyft) remains prohibited.
- Alcoholic beverages delivered to a person must be for personal use and not for resale.
- Sales should be limited to only alcoholic beverages the business is currently licensed to sell.
- All alcoholic beverages must be in sealed containers and comply with open container laws, therefore it must be transported in the trunk of the vehicle or, if the vehicle does not have a trunk, behind the last upright seat of the vehicle.
- We recommend alcohol be packaged in a stapled or sealed paper bag to ensure its contents have not been opened or tampered with.

## Best Practices for Cocktail Takeout:

### **Reno, Sparks, Washoe County**

- Valid proof of the recipient's identity and age (21 or older) **MUST** be obtained at the time the alcohol is delivered.
- Alcoholic beverages purchased via takeout must be for personal use and not for resale.
- All alcoholic beverages must be in sealed containers and comply with open container laws, therefore it must be transported in the trunk of the vehicle or, if the vehicle does not have a trunk, behind the last upright seat of the vehicle.
  - Businesses must register with the City of Reno and include further information as well as an image or description of the take out container.
- We recommend alcohol be packaged in a stapled or sealed paper bag to ensure its contents have not been opened or tampered with.
